4. Stormwater Management Plan (per the Massachusetts Stormwater Management Regulations and Massachusetts Stormwater Management Handbook as applicable for the scope of the project.)
5. Supporting Stormwater Management Report and engineering calculations (per the Massachusetts Stormwater Management Regulations and Massachusetts Stormwater Management Handbook as applicable for the scope of the project). The report must contain a narrative describing the project and how the project will comply with the Maynard Stormwater Management Bylaw. List any requested waivers and the reasons the standards can not be met.
6. Stormwater Pollution Prevention Plan (SWPPP) if coverage is required under the U.S. EPA Construction General Permit, Multi-Sector Permit or an individual permit under the NPDES Phase II requirements.
7. Long-term Pollution Prevention Plan
8. Erosion and Sediment Control Plan
9. Stormwater System Operation and Maintenance Plan
