

**Maynard Board of Health Meeting Minutes
July 1, 2025 (June Meeting)**

The Maynard Board of Health met on Tuesday, July 1, 2025. In attendance were Kathy McMillan, Maura Flynn and Lisa Thuot; also from the town were Moira Carter, Public Health Nurse; Steven Silverstein, Executive Director, Municipal Services.

I. Call Board of Health Meeting to Order

A motion was made by Kathy, and seconded by Maura to open the Board of Health meeting at 6:39pm. Motion supported unanimously.

II. Public Comment

Call made for public comments; there were no comments.

III. Tobacco Sale Violations

**a. Deliberation and Conclusion of Appeal of Violation by Mr. Mrugesh Patel, 49
Walnut Street, "The Corner Store"**

Kathy noted that Mr. Patel admitted he had taken the course given by tobacco coalition and signed off on same. Lisa stated she did not feel comfortable coming down on the appellant for the fact of selling flavored tobacco products, as it was not being tested reasonably. Board agreed that Corner Store was selling the product at the time of the violation.

Steve explained that there were two different questions being discussed, the former a longer-term, more philosophical one, and the latter question the one that was germane to this hearing:

- 1) Does the BOH agree with the regulations on the books and their application;
- 2) In the present case did the appellant break the laws that are on the books?

The Tobacco Control Alliance (TCA) was concerned that BOH had been ok with the regulations in the past, but was now suddenly changing its views. The Board needs to decide if a violation occurred or not.

BoH agreed there needs to be a better definition of what "characterizing flavor" is and seems state as well has to get a handle on this issue, considering the marijuana industry is selling flavored products, too. BoH agreed that it appeared that owner bought the offending products in good faith, thinking that they were legal for sale according to the list the distributor provided him.

In 2023, at the time of previous violations were issued against The Corner Store, BoH waived the fine and put in place a one day suspension, on condition that the store committed no other violation within the following 36 month timeframe.

BoH then discussed what type of fine to give, i.e. whether they would accept the recommendation of the TCA or whether they would attenuate the monetary fine and/or the permit suspension component.

Kathy made a motion for a finding that the violation was committed and the fine would be suspension for 6 days with no monetary fine to begin Friday, July 4th; vote taken:

Kathy - yes
Maura – yes
Lisa – yes

BoH agreed to draft a letter informing the appellant of the finding.

IV. Resident Complaint Debris and Trash Accumulation at 3-22 Railroad Street

BoH was informed that a resident complained about the property, which, in its shared yard, has “trash piled near river, a trash mound, old appliances,” etc. It was mentioned that it is the landlord’s responsibility to clean up the trash; that there is a history with this owner for other violations; and that there is a property management company, yet the property is still unkempt. BoH agreed that a written warning should go to management/landlord informing 30 days to clean up, and if not then the town will take the property owner to court. All members were in agreement with this course of action.

V. Green Maynard correspondence

Kathy advised the Board that she has been requested to attend Select Board meeting re: Green Maynard complaints about local businesses using plastic bags in violation of town bylaws.

Kathy planned to attend the July 15th Select Board meeting and would use the opportunity to stress the fact that the town has not had a health agent in over 8 months and that Casey Mellin, temporary health agent, was used for inspections when available, but that he works through MetroWest Shared Public Health Service, which is only meant only to supplement and provide capacity building (and not to serve in place of a permanent health agent).

We advised Green Maynard at time we did not back the polystyrene ban as we do not have staff to do inspections for bags and same...we asked Green Maynard to educate the Maynard businesses regarding the bags etc. They agreed to inspect and BoH could police

VI. Update from Public Health Nurse

a. Public health report

2 cases of human granulocytic anaplasmosis, 4 cases of Lyme – Bacterial and can be spread by black legged deer ticks; 2 flu, 2 Covid-19 cases; 1 varicella/shingles. None required any action by nurse.

Community outreach and education: Presented the community health needs assessment to the Select Board in May. Gave a mental health and how we can support it ourselves, to our loved ones our community talk at library beginning of May. Started Health Communications Board in downstairs hallway, good resources.

Moir participated in a climate hazard roundtable discussion with MetroWest Shared Public Health Services and MAPC more documentation to be distributed from them

Working on applying for a grant through Emersons community benefits regarding social isolation funds, notified recently Maynards proposed project for a rise and shine social pancake breakfast was granted full funding of \$100. Estimating late summer/fall. Police and Fire to cook the breakfast, continuing to work on logistics.

Members continue to have issues being able to log into town emails. Steve will discuss with DriveTech again and maybe have them attend meeting or provide written instructions... Question about having on phones as well.

Kathy signed the Beaver Trapping consent for Justin and Greg...
