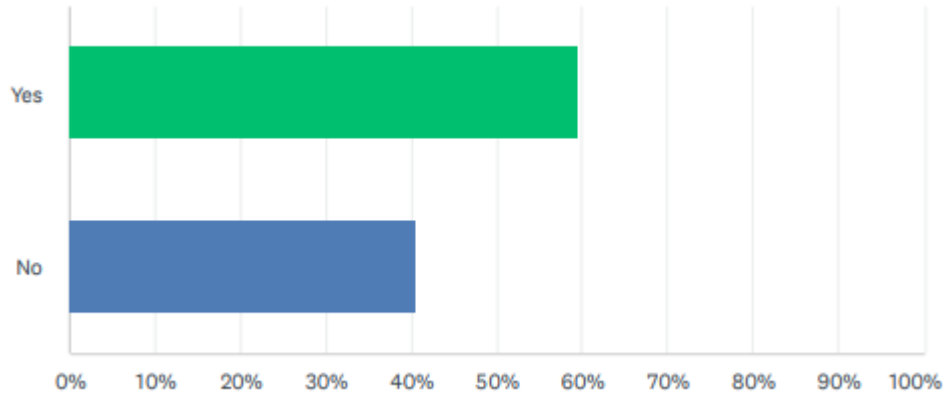
Thank you everyone for your survey participation and also thanks to the open mindedness of all town departments for improvement.

Q1 Did you attend the 2022 Special Town Meeting on October 24th?

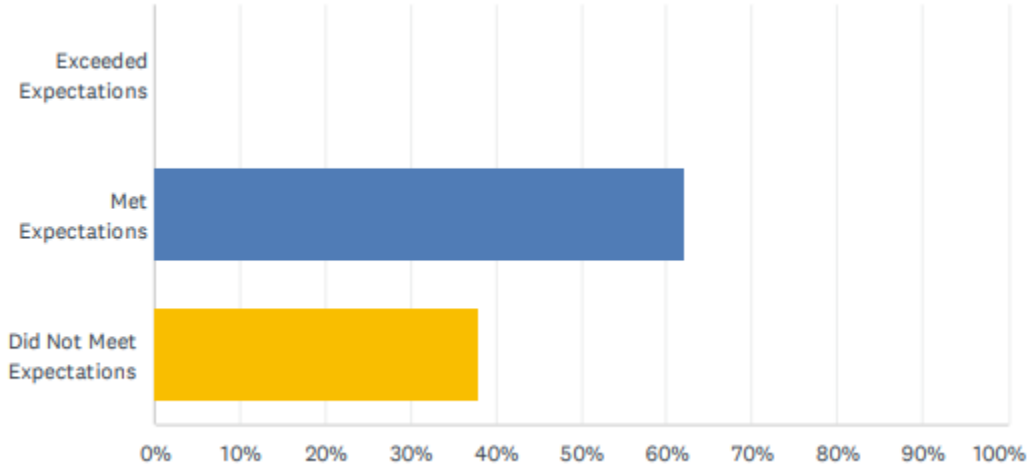

Our normal procedure is to post it on a sign in front of town hall, to the town web, place in the Action newspaper, and on the Town's Facebook page as well as an announcement on HyperReach (aka: Reverse 911 and Robocall). Nevertheless, We plan on further promoting Town Meetings such as making more people aware of HyperReach for Mobile phones, texts and email so that more people get updates. 2	<p>For one, the moderator should not use his ability to have the last word on an article to endorse any article...how is that constitutional?</p> <p><i>Good Point. I did have some concerns myself. A few folks made comments about the Town Meeting being legislative and the SelectBoard being administrative. There was the implication the Selectboard was usurping power of the Town Meeting who should dictate certain things. I didn't want voters to be left with the wrong impression of each group's responsibilities. Town Meeting establishes policy and sets the financial pot of money, but it is the responsibility of the administrative branch of government thru the SelectBoard to run the day-to-day activities. They review what research they have done and why they recommend, or not recommend for each article. Attendees are encouraged to ask questions. To give the same level of detail at the Town Meeting could prolong the meeting to potentially two nights. This was how things were back in the 70's and 80's. We have streamlined the meeting as best as we can without affecting the voters' ability to ask questions and make comments. Secret ballots are alternated to reduce dead time. 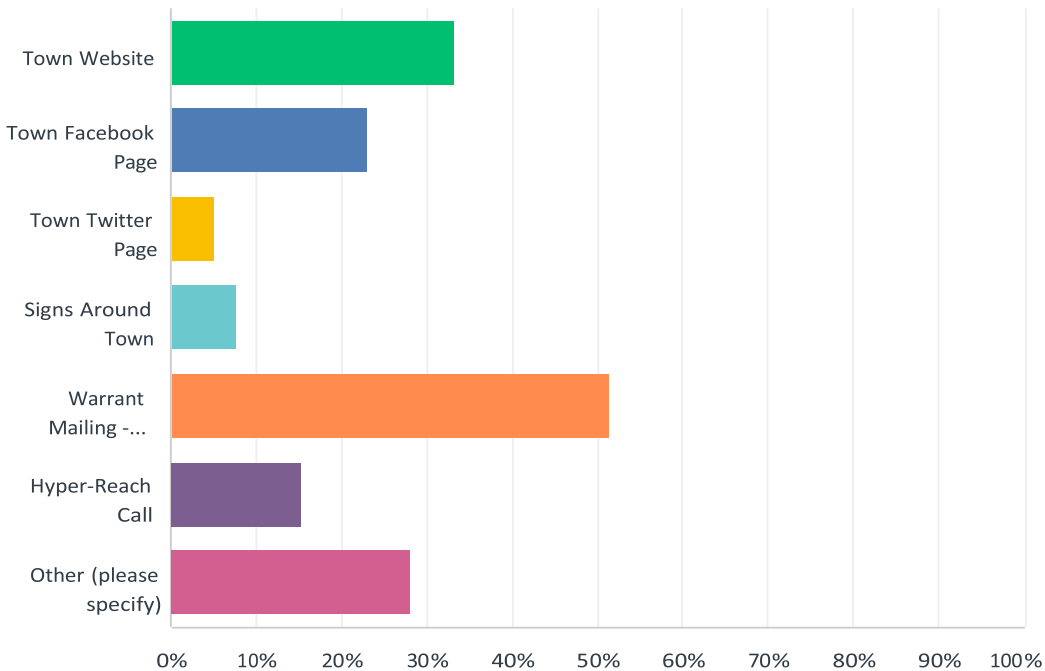
