ADMINISTRATION

- Town Administrator (TA) Johnson and Assistant Town Administrator (ATA) Stephanie Duggan are conducting regular collective bargaining agreement negotiations with the IAFF Fire Fighters Local 1947 union, and with the Public Safety Tele-Communicators NEPBA Local 114 dispatchers union.
- TA Johnson issued the Request For Information (RFI) to seek potential spaces to lease for a senior center. The RFI is available through registration on the town's website.
- TA Johnson joined the other members of the Green Meadow School Building Committee on Monday, July 8, 2024, to review the current design details of the new facility, with attention to cost and scale of design elements.
- TA Johnson congratulated the owner of Bagel Table for the opening of their latest location on Main Street on Thursday, July 11, 2024.

Incidents:

- On June 5th, 2024, Officer Blackington took a report of a laptop that was stolen from a residence. The laptop was entered as stolen into NCIC and the matter is under investigation.

- On June 23rd, 2024, Officer Oliveira took a report of vandalism to flowers and flowerpots on Naylor Court. Some of the plants had been pulled out of the soil and nip bottles were left in the planters. The incident was documented, and photographs were taken.
- On June 28th, 2024, Officer Blackington took a report of a wallet that was stolen from the parking lot on Digital Way. A credit card was used in Maynard and Marlborough. The incident is under investigation, and the individual was advised to contact the credit card/bank immediately to cancel cards.
