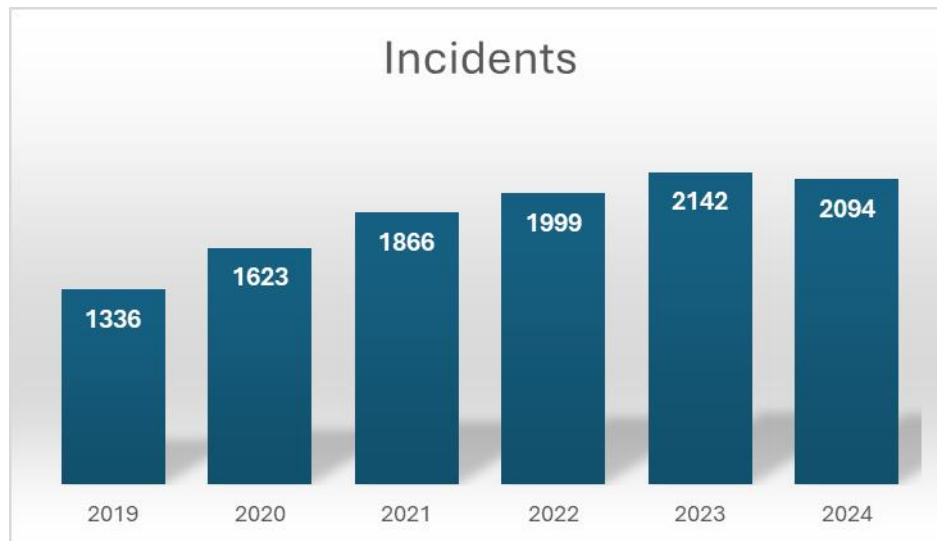


ADMINISTRATION

- Town Administrator (TA) Johnson and Assistant Town Administrator (ATA) Stephanie Duggan are expecting to begin regular collective bargaining agreement negotiations with the LIUNA Professionals union and LIUNA Laborers union. TA Johnson expects to begin negotiations with Director of Public Works (DPW) Justin DeMarco. TA Johnson is conducting negotiations with Chris Troiano to serve as Police Chief.
- Town Hall, the Police Station and the Fire Station phones have been replaced with a new internet-based system through vendor “Harbor Networks”. The new system allows users to use their computer and mobile devices to make calls, check voice mail, send text messages, and host video conferences.
- TA Johnson and Executive Director of the Office of Municipal Services (OMS) Steve Silverstein opened the proposals for the sale of 61-63 Summer Street (old Fowler School). An evaluation team is being formed to review the proposals and develop a recommendation for the Select Board to authorize the Town Administrator to negotiate sale terms.
- TA Johnson expects to brief the Budget Sub Committee on Wednesday, January 22, 2025, with his recommendations for the Fiscal Year 2026 (FY26) General Fund budget and capital improvement plan (CIP).
- TA Johnson and ATA Duggan plan to attend the “Connect 351” annual conference of the Massachusetts Municipal Association (MMA) at the Seaport District, Boston, on January 23-25, 2025.
- An Insurance Advisory Committee (IAC) meeting, composed of union and other employee representation, is scheduled for Tuesday, January 28, 2025, to review reports from the town’s health insurance provider, MIIA, provided at the MMA Annual Conference.
- TA Johnson thanks the organizers and participants that made a successful “Winter Fest” on Saturday, January 18, 2025.

FIRE

Analysis of our 2024 data is currently underway. We responded to a total of 2,094 emergency calls, which represents a slight decrease compared to the previous year. Nevertheless, the overall trend remains upward. The Digital Way complex emerged as our largest response area, with 350 requests for service.



Our year began with a brush fire sparked by an unattended fire pit. The Commonwealth continues to face challenges due to the drought conditions experienced in 2024. Moving forward, we are committed to enhancing public education on fire safety, particularly during the Open Burning season. Should these conditions persist, we anticipate that the state may shorten the open burning season.



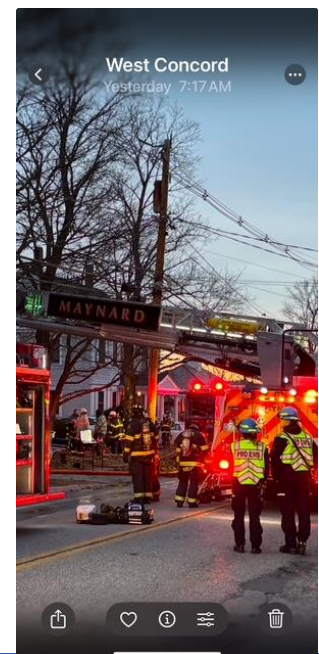
On the night prior, the Engine Company from Group 3 responded to a fire in Maynard. Early the following morning, the Ladder Company from the same group was dispatched to Concord in response to a mutual aid request for apparatus to assist with a working structure fire.

This week, we are conducting a promotional exam to fill the open Captain position left by Captain King's retirement in December. Additionally, we are excited to put our new Engine 1 into service on January 9th, marking this significant milestone with a push-in ceremony. We recognize the crucial role public support plays in securing funding for public safety, and we have invited community members to join us in commemorating this event.

A special shout-out goes to Firefighter Brian Kramer, who served on the apparatus design committee alongside Chief Lawless. The design process for this engine began in December 2021, with delivery completed in October. Preparing an apparatus for service is no small feat, requiring immense time and dedication. Many of our members have worked tirelessly over the past few months to ensure this Engine is ready for service, and we are thrilled to bring it into service for the community this week.

We also recently completed a hiring process and are pleased to welcome our newest member, Firefighter Edward Noland. A Boston resident, Mr. Noland previously served as a full-time firefighter in Nashville, TN. After the birth of his first child, he and his wife returned to Boston, and he now looks forward to joining the Maynard Fire Department.
