Meeting Minutes – October 30, 2018– 6:30 p.m.

The Maynard Board of Health held a scheduled meeting on Tuesday, October 30, 2018 at the Maynard Town Hall beginning at 6:30 p.m., Ronald Cassidy, Kathy McMillan and Lisa Thuot were present. Also present was Kelly Pawluczzonek, Health Agent. Kathy McMillan made a motion to open the meeting at 6:32 pm, Ronald Cassidy, Seconded, all in favor.

New Business:

The Town of Hudson will be covering Kelly's maternity leave. Hudson covered Kelly's previous maternity leave back in 2016.

Olaf Ingare from Mass WellSpring met with the Board of Health to discuss potential Marijuana Regulations that the Board has drafted. The Board also asked questions in regards to Roll-Your-Own machines, training requirements, security systems, Hemp, and CBD products.

Massachusetts has amended the State's tobacco laws. As of December 31st, 2018 the State of Massachusetts will be enforcing the minimum legal sales age to buy tobacco and nicotine products to 21. However, there is a grandfathering clause that states that if you turn 18 prior to December 31st then you can purchase. Maynard already passed a regulation to have the minimum legal sales age to 21 several years ago.

The State of Massachusetts has also adopted The 2013 Federal Food Code. Kelly stated that the changes are still being reviewed. Beth Grossman, the Town's food consultant will be offering trainings for both establishments and inspectors to discuss trainings.
